GOVERNMENT OF PUNJAB DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HOUSING II BRANCH)

No. 4966-CTP (Pb)/SP-458 Dated: 02.09.2014

Whereas the development of colonies, Mega Housing Project, have been approved under the provisions of the Punjab Apartment & Property Regulation Act, 1995, Mega Housing Policy. However, the present frame work does not provide the clear procedure to issue completion or partial completion to such projects. A number of approved projects in the state are awaiting issue of completion/partial certificate which is causing hardship to promoters & residents of such projects for the maintenance & upkeep of public utilities & services.

To streamline the issue of completion/ partial completion certificate for PAPRA & Mega Projects falling outside municipal limits, its procedure and time frame etc., the detailed guide lines/procedure has been worked out which is as under:-

Completion Certificate:-

"Completion Certificate" means a Certificate issued by the Competent Authority on written request of the applicant or promoter after completion of building works including all services or utilities as provided in the sanctioned building plans in case of a building and in case of a colony under the Punjab Apartment Property Regulation Act, 1995 or the Mega Projects policy on completion of development works viz. roads, water supply, sewerage and drainage system, street lighting parks and other utilities as provided in the layout plan of the colony or project.

Provided that the economically weaker section component of the colony or project has been duly completed by the applicant or promoter as per policy of the State Government.

Provided further that the applicant or promoter has made all payments or charges to the Competent Authority and the area under roads and parks have been duly transferred to the concerned Authority by the applicant or promoter.

Partial Completion Certificate:-

Partial completion for various types of projects shall mean as under;

1. Partial Completion of Land Development Projects.

May be issued, if the promoter fulfills the following conditions;

- i. The minimum area for which partial completion certificate is sought should not be less than 25 acres.
- ii. The layout of entire project area should be demarcated at site as per approved layout plan.
- iii. The construction of approach road to project and connectivity to all the public utilities and services is complete and operational.
- iv. All the public utilities and services should be operational in that part of project for which partial completion certificate is sought viz; Water supply, sewerage, Storm Water drainage, ,Fire Fighting Services, HT/LT Street Light, Parks etc. and outfall sewer lines should be laid upto Sewage Treatment Plant.
- v. Mandatory clearances such as Environment clearance, Fire safety, NOC from National Highway Authority in case of approach from N.H., NOC from Forest Deptt. for the entire project, should have been obtained, if applicable.
- vi. Test Certificate for commissioning of Transformers duly issued by Chief Electrical Inspector, Punjab.
- vii. NDC for upto date payments of due charges and fees from the concerned development authority for entire Project.
- viii. Proportionate construction of E.W.S Houses or transfer of land reserved for EWS to the Development Authority as per policy should be complete.
- ix. Arrangements for water harvesting system as per approved plan.

2. For G.H. Projects

- i. The construction of approach road to the project and other roads connecting all the public utilities and services is complete and operational.
- ii. Construction of complete G.H. Block (s) as per approved building plans/design and specifications should be complete in all respects for which completion certificate is sought.
- iii. All the public utilities, services & Fire Fighting arrangements should be complete and operational for the cluster or building block for which completion certificate is sought.
- iv. Mandatory clearances such as Environmental Clearance, NOC from Air Port Authority, NOC for fire safety & NOC from National Highway Authority, (in case approach is taken from N.H) for the entire approved project are obtained.
- v. Test Certificate for commissioning of Transformers duly issued by Chief Electrical Inspector Punjab.
- vi. NDC for upto date payments of due charges and fees from the concerned development authority for entire Project.
- vii. Certificate of qualified structure Engineer (with minimum post-graduate degree, having 5 years experience) regarding safety of the structure.
- viii. Proportionate Construction of E.W.S Houses or transfer of total Land reserved for EWS as per the conditions laid down in the EWS policy dated 31.12.2013 to the Development Authority.
 - ix. Development of proportionate minimum parking space for the area for which completion certificate is sought.
 - x. Installation of Solar Water Heating and Lighting System.
- xi. Arrangements for water harvesting system.
- xii. Certificate from Bureau of Energy Efficiency (BEE) or GRIHA or IGBC in case incentive of additional FAR have been claimed under green building category.
- xiii. Undertaking by promoter for maintenance and operation of public utilities for minimum period of five year or till handing over the project to Resident Welfare Association (R.W.A)

3. For Commercial Building, Hotel and Multiplex.

- i) Construction of complete floor (s) of the Building with complete provision of public toilets, Fire Safety arrangements, ramps etc., in all respect for which the completion certificate is sought. In Case partial completion certificate is sought for any floor(s) the super structure of that building or block should be complete as per approved building plans with finished facade.
- ii) The minimum proportionate parking space for the area for which completion certificate is sought should be complete & operational.
- iii) Mandatory clearance regarding fire safety, Height of Building, Environment impact assessment (if required) etc. for the entire approved project are obtained & public toilets and stair cases for general public & handicapped and disabled persons are completed and made operational.
- iv) Certificate from Bureau of Energy Efficiency (BEE) or GRIHA or IGBC in case incentive of additional FAR have been claimed under green building category.
- v) Test Certificate for commissioning of Transformers duly issued by Chief Electrical Inspector, Punjab should be submitted.
- vi) Arrangements for water harvesting system.
- vii) NDC for upto date payments of due charges and fees from the concerned development authority for entire Project.
- viii) Installation of Solar Water Heating and Lighting system if applicable.
- ix) Certificate of qualified structure Engineer (with minimum post graduate degree and 5 years of experience) regarding safety of structure.

4. For Institutional/ Public Buildings forming part of PAPRA/Mega Projects.

i. The partial completion for the part of building block in case of Institutions/public buildings should not be applicable. However partial completion at the project level may be issued provided that the building block for which partial completion is sought should be complete as per approved building plans and specifications.

- ii. Approach road to the project site should be complete and operational.
- iii. Provision of all public utilities & services of the block for which completion certificate is sought should be complete with common services to the entire project.
- iv. Provision of public toilets, stairs and ramps for handicap and disabled persons.
- v. Mandatory clearances such as Environment, approach road, Forests, Fire Safety etc. are obtained.
- vi. Certificate from Bureau of Energy Efficiency (BEE) or GRIHA or IGBC in case incentive of additional FAR have been claimed under green building category.
- vii. The minimum proportionate parking space for the area for which completion certificate is sought is constructed and operational.
- viii. Installation of Solar water Heating and Lighting system, if applicable.
- ix. Test Certificate for commissioning of Transformers duly issued by Chief Electrical Inspector Punjab, if applicable.
- x. Arrangements for water harvesting system.
- xi. NDC for payment of all the charges and fees.
- xii. Certificate of qualified structure Engineer (with minimum post graduate degree and 5 years of experience) regarding safety of structure.

Note: (i). The time of partial completion certificate shall be exclusive of the minimum period of five years to be counted for the maintenance of project from the date of issue of completion certificate.

I) Procedure for issue of completion/partial completion certificate:

"Competent authority" for the purpose of issue of completion/partial completion certificate means:-

- Chief Administrator of concerned Development Authority for the land development projects approved under Punjab Apartment and Property Regulation Act, 1995 and Mega Projects Policy.
- Additional Chief Administrator of concerned Development Authority for buildings under Group Housing, Commercial Complexes, Institutions, Hotels, Multiplexes & Public Buildings forming part of PAPRA/Mega Project.

1. How to apply for issue of Completion/ partial completion certificate:

The information listed in the following table shall be submitted by the promoter along with a forwarding letter to the competent authority for the project for which the completion/partial completion certificate is sought:
